## FOR STUDENTS ENROLLED IN "2019-2020" JCTC 11th Grade College Core

Students enrolled in the Junior College Core Program at Oldham County High School are extended the privilege of leaving campus on the days on which the classes do not meet or occasional days where class has been cancelled. The privilege to leave campus is limited to the same time during which the course meets on class days. In order to exercise this privilege, students must be a junior with an A/B average, must have parent/guardian permission, and must sign-in and sign-out with the attendance clerk. The student must be wearing their college lanyard in order to sign in or out of campus. In addition, there may be days students are asked to come in on their off days. Failure to comply or follow these rules could result in losing the privilege to leave campus.
